You are receiving this email as you have signed up for the SCC Packet Message passing exercise that opens at 09:00 this Wednesday and closes on next Tuesday at 17:00. If needed, please (re)review the event posting as well as the [monthly message passing practice training page](#) for information on drill simulation process flow and review any **Updated** and **New** information as there have been changes since the last practice.

1) Simulated Scenario for this month's exercise: Two days ago, Xanadu County experienced a 7.1 earthquake located in the ocean 28 mi WNW offshore from the scenic coastal City of Xanadu. The city is dealing with widespread damages and power outages. Both the City of Xanadu EOC and the Xanadu County EOC have been activated. You have been assigned as a packet radio operator for the City of Xanadu Emergency Operations Center.

2) Assignment details for mutual aid volunteer consideration

Agency:	City of Xanadu
Event/Incident:	Earthquake, Activation #: XND-24-1211P
Assignment: (simulated)	Provide packet operator services for EOC communications.
Requested arrival and Operational Period:	For this simulation and practice, you have been assigned to the second operational period of Xanadu City's activation. The prior packet operator checked-out with Xanadu County EOC. Your actual practice operational period begins with the download of any pertinent BBS notices prior to your check with the Xanadu County EOC and ends with your check out and subsequent transmission of the required participation turn-in materials to the practice instructor.
Simulated Reporting Location:	City of Xanadu EOC is sufficient for this practice.
Contact on arrival:	Shangdu Khan, Incident Commander.
Travel info:	All major roads are clear at this time.

Message 2: JurisStat - Immediate

- Issues noted
 - This is the second message in the PDF for “ALERT: Your manager just handed you the following two messages.”
 - Two stations didn’t send the Immediate at all, otherwise all Immediate
 - Several stations didn’t read the entire “You have been handed message”
 - Got hung up waiting for response without reading instructions at the bottom
 - Of the stations that sent the Immediate
 - 7 stations didn’t used the simulated voice net for Immediate message pickup
 - Most every station sent the simulated voice/sms message within 5-6 minutes
 - XNDEOC “polling loop” is 3 minutes
 - One station > 20 minutes
 - Received voice/sms message before JurisStat was received from a few stations
 - Waited for BBS session to be completed?
 - Otherwise, might be able to explain with poll time granularity
 - Same issues with ICS To Location
 - One stations didn’t see pages 2 and 3, one missed activation “full” button

Packet ICS 309

- All top and bottom looking pretty good
- Two missing the Immediate message
- One 309 not received
- Several did not include the messages sent after XNDEOC received the Check Out:
 - Thank you
 - Knowledge
 - Delivered receipts (if any)

Voice ICS 309

- NOT GOOD
- Seven of the stations that left a simulated voice message did not turn in a voice 309
- Expected: the two stations that didn't send a voice message
- Voice ICS309 not counting for participation this month
 - Happy Holidays!
- In 2025 instructions will be more clear about use of simulated voice net for Immediate messages (only) and voice 309
